Conditions and Procedures of Issuing the Permit	<ol style="list-style-type: none"> 1. To issue the permit, the applicant shall obtain the initial approval of the licensing authority in the Emirate. 2. The owner of the establishment, or his legal representative, submits the permit application prepared by the RTA through its approved service delivery channels, accompanied by the following documents: <ol style="list-style-type: none"> A. The initial approval to conduct the activity issued by the licensing authority in the Emirate for new establishments, and a copy of the commercial license for existing establishments. B. The approval of the competent authority to carry out the activity if the legislation in force requires obtaining such approval. C. A copy of the valid passport or identity card of the establishment's owner and all partners, in addition to a copy of the valid residency voucher for the non-citizen partner. D. An undertaking to abide by the conditions and requirements necessary to carry out the activity. 		
Responsibilities of the Entity	<ol style="list-style-type: none"> 1- Comply with the regulations, resolutions and instructions of the RTA regarding the activity. 2- Provide an office, bikes and parking spaces commensurate with the nature of the activity authorized to be practiced, and comply with the controls and standards approved by the Agency in this regard. 3- Carry out the activity specified in the permit. 4- The vehicle designated to carry out the authorized activity shall be registered in the Emirate of Dubai, whether it is owned or leased by the establishment. 5- Not to assign the permit to a third party or dispose of it in any way, except after obtaining the prior approval of the Agency. 6- Use the parking spaces approved by the RTA and concerned bodies in the Emirate when practicing the activity. 7- Cooperate with RTA officials and those authorized by the RTA, and provide the Agency with the required information and documents. 8- Comply with the technical requirements of the bike, approved by the Agency and the competent government authorities, according to the activity authorized to be practiced. 9- Obtain licenses and permits required by the legislation in force in the Emirate. 10- The bikes in which the activity is carried out shall be inspected when licensing or renewing its license at the service centers specified by the Agency in this regard. 11- Not to stop practicing the activity without obtaining the prior approval of the Agency. This approval shall be issued in accordance with the conditions and procedures adopted by the Agency in this regard. 12- Keep records that include all data related to the practice of the activity for the periods specified by the Agency in this regard. 13- Obtain the approval of the Agency in case of changing the location of the establishment. 14- Adhere to the terms and conditions of the approved technical examination determined by the Agency. 15- Install a tracking system, a speed limit system, or other systems specified by RTA or the competent authority. (if any) 16- Fulfill the security and safety stipulations set by the concerned body. 17- Provide bicycles to suit the type of activity. 18- Not to engage in electric scooter rental activity. 19- Use the motorbike for authorized use only. 20- Provide bikes with the years of manufacture and specifications determined by the Agency and competent authority, as the case may be. 21- Subscribe and register in the systems and platforms approved by the RTA, including the system. 22- Agree to undertake to comply with the additional requirements set by the Agency. 		



	<p>23- Do not rent bikes for use in delivering orders except to companies authorized to do so.</p> <p>24- Comprehensive motorcycle insurance with one of the insurance companies licensed in the country</p> <p>25- Providing shock-protective head covers in multiple sizes and not renting a bike without a head cover.</p> <p style="text-align: center;">Special requirements</p> <p style="text-align: center;">New bikes (must meet all requirements below)</p> <p>26- It must be from within the country from an authorized agent - zero kilometers.</p> <p>27- Controls for bicycle registration: The year of manufacture of the bicycle must not be less than (6) years from the year in which the vehicle is registered.</p> <p>28- Vehicle replacement age: It is mandatory to replace a registered bike after (6) years from the date of registration.</p> <p style="text-align: center;">Used and imported bicycles: (must meet all requirements below)</p> <p>29- Controls for registering a bicycle: The year of manufacture of the bicycle must not be less than (6) years from the year in which it is registered, provided that it passes the technical inspection.</p> <p>30- Bike replacement age: It is mandatory to replace a registered bike after (6) years from the date of manufacture.</p>
