Conditions and Procedures of Issuing the Permit	<p>Issuing a permit to practice the activity:</p> <p>A. Establishments wishing to carry out the activity of transporting passengers in luxury vehicles shall be authorized according to the following procedures:</p> <ol style="list-style-type: none"> 1. Submit an application for the issuance of the permit to the Agency, supported by the following documents: <ul style="list-style-type: none"> • A copy of the passport, for citizens of the country. • A copy of the passport and residence permit, for non-citizens of the country. • A copy of the ID card. • Initial approval issued by the relevant commercial licensing authority to practice the activity by the permit applicant. • Feasibility study for carrying out the activity. • Any other documents determined by the Agency. 2. The Committee shall study the application and verify that it fulfills all the required conditions and documents. 3. In the event that the permit applicant fulfills all the requirements and conditions for practicing the required activity, the necessary recommendation shall be submitted to the CEO. 		

	<p>4. Regarding the possibility of obtaining a permit or not.</p> <p>5. Grant the permit to the applicant who fulfills all the required conditions and documents, after paying the prescribed fees.</p>
<p>Licensing Conditions and Entity's Obligations</p>	<p>In order to issue a permit to carry out the activity of transporting passengers using luxury vehicles, the following are required:</p> <ol style="list-style-type: none"> 1- Submit a feasibility study that includes the following: <ul style="list-style-type: none"> • Luxury vehicle running mechanism. • The proposed financial budget for conducting the activity. • The administrative structure, human resources and expertise that will be used to carry out the activity. 2- Submit a cash or bank guarantee issued by one of the banks operating in the country in favor of RTA, as determined by the concession contract, in order to ensure that the establishment fulfills its obligations stipulated in Executive Council Resolution No. 6/2016 referred to, this Resolution and the concession contract. 3- Provide a suitable headquarters to manage and operate luxury vehicles, equipped with facilities and requirements as determined by the Agency in this regard. 4- Provide an undertaking to comply with the rate determined by RTA to collect the tariff, and the tariff collected shall be higher than the taxi tariff. 5- Provide an undertaking to link the electronic media and relevant smart applications and systems to the electronic platform, in the manner specified by the Agency in this regard. 6- Provide an undertaking to abide by all service level agreements, as determined by the Agency in this regard. 7- Pay the prescribed fee for issuing the permit. 8- Provide an undertaking not to operate luxury vehicles until after signing the agreement. 9- Provide an undertaking to adhere to the categories of luxury vehicles, the number allowed to be operated, the maximum duration of their use, and the type of vehicles used, as approved by the Agency in this regard. 10- Any other conditions determined by the Agency.
